# Review of Polling Districts, Polling Places and Polling Stations 2019

We are pleased that the proposal to change the polling place and polling station to the University of Worcester's Riverside Building (Severn Campus) from the Y.M.C.A. has been successful; however, we wanted to raise our concerns that the appeal to consider moving the Oldbury Park Primary School polling station to the University's St John's Campus has not been accepted.

We understand that our letter, dated 4 November, to members of the Personnel and General Purposes Sub-Committee, to appeal the decision by the Returning Officer to reject the use of the University's St John's Campus, was discussed at that Sub-Committee on 4 November 2019, with several members expressing their support for the change.

Therefore, we were disappointed to learn that this appeal was not accepted. We have been informed that this is because the Returning Officer felt that Oldbury Park Primary School had overcome safeguarding issues and that the Edward Elgar building would be 'too busy' with through traffic of people.

We would respectfully argue that the School remains highly concerned with the safeguarding risks of using their School as a polling station. The Head Teacher has explained that, in order to make the School safe, public money would have to be spent on temporary fencing in the School's driveway and playground; for the School Site Manager to be present for extended unsociable hours whilst the School is in use as a polling station, and for external security personnel to be on site throughout the day.

The Head Teacher is therefore considering closing the School on Election Day.

Closure of a school is a last resort for any Head Teacher and is not a decision made lightly. In addition to children missing a day's lessons, and cancelling the dress rehearsal for the Nativity Play, the impact on parents of having to make alternate childcare arrangements would be deeply disruptive.

This could be avoided by using the University's proposed polling place and is something the Head Teacher remains fully supportive of.



In terms of the Returning Officer's concerns about the Edward Elgar building, the University can assure the Council that it would take every effort to ensure that the polling station had a dedicated entrance and a clearly marked route to assist the public with locating the polling place.

To provide context for Council members, the option to consider a polling station at the St John's Campus was raised at the University Community Forum, a meeting held three times a year to promote partnership and community relations between residents, councillors, officers and the University, on the 29 May 2019.

The proposal was well received by the members of the Forum and it was agreed it would be progressed further with the City Council.

The City Council had two positive visits to the St John's and Riverside sites and no material concerns were raised regarding the proposed sites.

In addition to the benefits of no longer needing to disrupt the operations of a school, there are many other clear benefits of using the University as a polling station, which include:

- The St John's Campus has a high level of accessibility to those with disabilities, including a complete mapping of the site on AccessAble and a range of specialist facilities, including a 'Changing Places' toilet. Accessibility is one of the legislative requirements regarding the designation of polling districts and polling places.
- In the event of a winter election the University has the resources and specialist equipment to clear snow from the paths and roads, ensuring the facilities remain accessible to all, particularly the elderly and disabled. The University in recent years has not closed its campuses due to heavy snowfall or ice. The St John's site is well lit and has PCSOs allocated to location.
- The polling place on campus would be clearly identifiable to voters. The Edward
  Elgar building is familiar with local residents, and the building is in a clear line of
  sight from Oldbury Road. The majority of the newer residents in the polling district
  are either students or new members of university staff, who are less likely to be
  familiar with Oldbury Park Primary School.
- The St John's Campus is served by the number 31 bus that drives through campus and has a stop directly outside the Students' Union building. This stop is nearer to the proposed polling place than the stop on Oldbury Road is to Oldbury Park School and will be familiar for the many residents of St John's who travel on this service.
- The University has offered to make the facilities available free of charge and provide free managed parking close to the proposed location. Complementary refreshments and toilet facilities would also be made available to the polling staff.



• The University has a statutory requirement to promote democratic engagement, including voter registration.

The Electoral Commission identifies that voter engagement with young people is a key concern. A polling place closer to a large number of young people has the potential to facilitate their engagement and increase voter engagement, a goal which has national cross-party support.

We also note that there seemed to be cross-party support in the House of Commons to consider moving polling stations out of schools in the debate at the end of October.

We respectfully ask the Council to consider the option outlined to move the polling station to the St John's campus to enhance accessibility and inclusion. We are happy to provide further information and, if appropriate, facilitate a visit to the site by members of the Council.

Dear Julian Pugh,

I am writing to you on a behalf of my school governors and my local school community as well as Villages' Multi Trust. For the last three years, our children's education has not been disrupted by an enforced closure for polling. As a governing body, we feel strongly that a precedent has been established, and that another location is able to serve the electoral ward.

With the review of polling stations across Worcester and the City Council proposing that we are again to be used as a polling station we would like to express our dismay and annoyance that the City Council considering our school. The governors and I are extremely frustrated as we feel that an alternative site has worked effectively for the past three years, setting a precedent.

The use of a school of 420 pupils will be extremely disruptive to our children and parents, any closure that potentially happens to fall during the week before KS2 SATs testing is always very disruptive and does not give our Year 6 pupils the consistency they need at an already stressful time.

Additionally, the disruption to parents to find alternative care for their children on polling days has historically proved very difficult. Many parents have previously expressed their annoyance and disappointment.

In a time when Central Government have a firm stance on absences from school, it feels that we are not helping matters by closing to be a polling station.

Unfortunately, we are unable to remain open during polling day, as the pupils cannot be fully separated from members of the voting public, thus safeguarding measures are seriously compromised. Previously when the school has used as a polling station, voters were seen wandering through other parts of the school, which is a security risk to the school as well as safeguarding issue.

We are happy for you to explore the potential use of the caretakers building or locating porta cabins however, we do have reservations that both these solutions will not be adequate for the purpose of a polling station.

In conclusion, I feel strongly that a precedent has been set over the past three years; therefore, The City Council should not be considering the school but continue to use the alternative location, which has been effective for three years.

I look forward to hearing from you in due course.

I have discussed with them at length that the election days create huge safeguarding issues for us as a school.

They have suggested a fence to protect the children and the use of a security guard at the gate for the duration of the time the children are in school. A polling clerk has not worked sufficiently for this purpose in the past.

Our Site Manager also has to work extra (unsociable!) hours on the election days. I would appreciate some reimbursement for this in addition to the nominal amount for heating and lighting please.

I am sorry that this is not a more positive letter. We have managed the voting for many years but have always been extremely uncomfortable about the way it jeopardises the safety of our children.

Moving forward, I would rather this school was not used as a polling station, but if it has to be, the above precautions would have to be in place.

Dear Mr Painter,

Thank you for your time and the opportunity to discuss the Review of Polling Places with you and your colleagues earlier today.

As discussed at the meeting, I have attached a summary of the legislative requirements (Representation of the People Act 1983) of the review which further clarifies the points you raised at the meeting. I have highlighted the paragraph in section 2 that states that the polling place must be an area in the district, unless special circumstances make it desirable to designate an area wholly or partly outside the district (for example, if no accessible polling place can be identified in the district).

I have also attached the map of the Electoral Ward for Battenhall which identifies those buildings/sites that have been assessed for their suitability and deemed to be unsuitable as they do not meet with the criteria set by the Cabinet Office/Electoral Commission as set out in the summary guidance and checklist of criteria attached.

I assume you are referring to me when you talk about Marks proposals? I have been carrying out the data gathering part of this review and have visited Cherry Orchard in person as part of this, meeting with a member of your team – the business manager.

As I said in my email to Jan we have so far been unable to find any alternatives to the use of the school but would still welcome any suggestions. As I also said to Jan, we would like to meet with you and try to find a way to come to an acceptable solution (but it would most likely not be myself involved in that meeting) for example we have worked with Redhill Primary and Pitmaston Primary to put measures in place that allow them to stay open while still serving as a polling station for the community. I will pass your direct email onto the Deputy Returning Officer who will no doubt be in touch shortly.

Hi Jan,

One of the main considerations for a polling station is that it must, unless there is no venue available, be in the polling district. St Marks Church is not only outside of both B2 and B3 polling districts but is in a different Ward – B2 and B3 being in Battenhall and St Marks Church being in Cathedral.

The proposal for polling district D1 is that we stop using a portakabin located on the Waverley Street playground car park and use St Marks Church instead. The main difference for you is that Battenhall holds City Council elections 2 out of every 4 years whilst Cathedral has a vacancy on 3 out of every 4 years. Including the County Council elections this would mean us needing to use St Marks Church every year.

We have been unable to find any alternative venue in polling districts B2 and B3 other than Cherry Orchard Primary School. The public consultation is still open on the City Council website if you wished to make a comment, we have been asking for suggested alternatives on there as well as carrying out our own search. When the Returning Officer does have to use a school he only requires them to provide a suitable room. It is the responsibility of the Headteacher or governors to consider any safeguarding measures and decide whether to close the school. We have worked with a number of other schools to find a way to ensure the safety of the pupils and allow the school to remain open on polling day and are hoping to arrange a meeting with the Headteacher of Cherry Orchard soon to discuss this.

Dear St Clement Councillors.

As you are no doubt aware we are currently undertaking a Polling Place Review, please don't forget to make any comments you may have via the survey on the Council website.

One of the locations we know we need to find an alternative for is the YMCA on Henwick Road which, for obvious reasons, will no longer be available to us. We are hoping to use your local knowledge to help find a replacement. Attached is a map of the Ward with the polling districts shown, as the polling station will be serving districts J3A and J3B it would ideally be located in one of those districts. Do you know of any suitable buildings in those areas?

However, accessibility for electors and particularly for disabled electors is more important than location — we would rather have a venue outside the polling district that is wheelchair accessible than one inside the district that has no disabled access. If there are no suitable locations inside J3A or J3B our probable next step

would be to consider putting the polling station in the existing venue of Oldbury Park Primary School, alongside the J4 polling station, as we know this venue is DDA compliant.

If there is a location inside the J3A or J3B districts where we could site a portakabin to use as a polling station please let us know this as well. But, the (Acting) Returning Officer may choose to propose placing the polling station outside the district rather than using a portakabin as there are still accessibility concerns with portakabins.

Whilst we would rather keep the polling station in the Ward we can consider venues just across the boundary into St John, they would need to be closer or easier to get to than Oldbury Park Primary School to be considered as an alternative for J3A and J3B electors.

In summary, could you please let us know:

- 1. Do you know of a potential polling station venue inside J3A or J3B?
- 2. Do you know of a site inside J3A or J3B that could house a portakabin polling station?
- 3. Do you know of a potential polling station venue outside J3A or J3B more convenient for electors than the alternative venue of Oldbury Park Primary School?

The closing date for comments to be received is 10<sup>th</sup> October 2019 and the (Acting) Retuning Officer will be considering all comments after that time with the final recommendation being considered by Personnel and General Purposes Sub Committee on 4<sup>th</sup> November and then Full Council on 19<sup>th</sup> November.

The (Acting) returning Officer is proposing to use Worcester Lawn Tennis Club as the polling place for polling district E1, as the Royal British Legion is located in polling district E1 which is further away to the majority of the electorate in E1. The Tennis Club is considerably closer the electorate within E1. As part of the consultation process a number of electors within polling district E1 have requested that the polling place be moved from the Royal British legion to the Tennis Club.

Thank you for the feedback from the polling station consultation so far.

With regard to polling stations in Claines, I note the proposal to move the Ombersley Road Methodist Church to Gheluvelt Sons of Rest. This makes sense as the Methodist Church is difficult to access if you have mobility issues. I do support this.

I also note the proposal to move the Claines Royal British Legion (CRBL) to the Worcester Lawn Tennis Club (WLTC), making WLTC a polling station for two areas. This concerns me greatly. Access to WLTC is via the narrow Northwick Close, situated alongisde Northwick Manor Primary School, home to 660 pupils when full to capacity, host to the resultant traffic and parking issues.

I would like to recommend maintaining CRBL as the polling station for one area and WLTC as the polling station for one area. CRBL has good access, unlike WLTC.

Having been a candidate in Claines for the last six local elections, I have understandably, spent a great deal of time around the polling stations. Also to add, retired local Councillors from Claines, recall WLTC being used for two areas in the past and it not working, due to the access problems mentioned above.
