Welcome

During 2021-2022 Worcester City Council will spend £22.5 million providing essential services to you. Our costs are increasing in line with inflation so this year our element of your Council Tax bill will again rise by around 1p per day in order to help us protect your services. You can find out how much you'll pay on page five.

Worcester City Council collects the Council Tax on behalf of Worcestershire County Council, the Office of the Police and Crime Commissioner for West Mercia, Hereford & Worcester Fire and Rescue Authority and, where necessary, your local parish council. The total amount is then split to provide the services that are part of your everyday life.

This year, the majority of Band D households in Worcester will pay £1,867.58 to their local authorities - that's just £35.91 a week.

Direct Debit – the best way to pay



Life is stressful enough at the moment, so make yours a little easier by paying your bill by Direct Debit - it can save you money, time and effort (because you only need to set it up once, not every year).

Over 76% of households in Worcester already pay this way – all you need to do is give us your bank account details and we can do the rest.

You have a choice of monthly payment dates - the 1st, 10th, 15th or 25th of the month, whichever suits you best.

And remember – your payments will always be covered by the Direct Debit guarantee.

Supporting Worcester through the pandemic

Covid-19 has affected everyone's lives and Worcester City Council has been at the heart of the local response to the pandemic. Council officers have gone to enormous efforts to keep essential services going – including recycling & waste collections, support for the homeless, looking after your parks and much more.

Other key tasks have included supporting vulnerable residents, awarding grants to city businesses, and assisting the national track and trace programme.

The City Council will play a central role in Worcester's recovery from the pandemic by promoting physical exercise, tackling homelessness, supporting volunteers and vulnerable people, helping victims of domestic abuse and many other measures – including the creation of a lasting memorial to those we have lost.

Ambitions for the future



Worcester City Council has prepared ambitious bids for national Government funding. Delivery of this funding will bring about a significant transformation of the city, creating new employment, new homes, and helping the city recover from the pandemic.

£17.9 million is to be invested from the Future High Street Fund. This will regenerate the northern end of the city centre, around Angel Street and Angel Place. Among other benefits, this scheme will bring the re-opening of a restored Scala Theatre and Corn Exchange and the creation of new homes for first-time buyers.

A bid has also been made to the Towns Fund for up to £28m. If successful, this will fund a range of projects including new homes and businesses at Shrub Hill; a new 'Building Block' construction skills training centre in Dines Green; new cycling and walking routes; a new medical training centre in Hylton Road; improvements to the riverside; and development of the city's tourism attractions, including The Commandery.

Investing in your city

This year the Council will invest more than ever in the city. Major improvements will be made in Worcester as part of the City Council's budget for 2020-21.

16.8m contribution to the Future High Streets Fund regeneration of Angel Place and the surrounding area

 £1.9m contribution to the demolition of the old Sansome Walk swimming pool, enabling the site to be used for new housing

- £1.3m contribution to The Arches Worcester project, creating a new destination at the city's historic Victorian railway arches
- £688,000 improving homes for residents
- £158,000 on new bins, including the installation of new compactor litter bins in the city centre
- £125,000 improvements to Astwood Cemetery & Crematorium

The City Council's share of the total Band D Council Tax is £195.88; this is a £5 rise on the previous year, but the increase is lower for the majority of city households.

Your Council Tax bill also includes charges for Worcestershire County Council, the Office of the Police and Crime Commissioner for West Mercia, Hereford & Worcester Fire and Rescue Authority.

The last year has been an exceptionally tough year for all of us. We are doing all we can to keep residents in Worcestershire safe, try to reduce the spread of the virus and support the most vulnerable in society.

Millions of pounds more have been invested into supporting local businesses through these very challenging times.

We recognise the difficulties that many households in Worcestershire are facing and because of that we are keeping our rise in Council Tax next year to 2.5%.

The increase is the equivalent to 63 pence per week for a band D property. This is lower than the increases that are being proposed in many areas and means that Council Tax rates in Worcestershire will remain amongst the lowest in the country for county councils.

We are planning to invest an extra £11.5 million (gross) into Adult Social Care to meet the needs of Worcestershire's ageing population. We are proposing to spend an additional £7.7m (gross) on improving outcomes for our children and young people.

Our budget for this coming year will also support the county's recovery from the pandemic. We plan to invest in those areas that residents have told us are most in need of improvement.

They include improving the county's roads and pavements, cutting congestion and improving public transport. We are also investing in schemes that will reduce the risk of flooding, improve our countryside walks and enhance the environment

I know the months ahead will remain challenging and we will continue to do all we can to protect the vulnerable, support the local economy and maintain vital public services.
