Virtual Season Permit Car Parking Scheme.

Terms and Condtions.

Virtual Season Car Parking permits are available in the Worcester City Council Amber and Green Zone car parks. They are *not* available in the red zone car parks.

The permit allows parking in any of the car parks listed in the zone that you choose, you are not restricted to just one car park. The permit cannot be used in any other car park not **in that zone**, they are not transferrable between zones.

The permit will **not allow** parking in any car park in the red zone at any time.

- Virtual season parking permits will be available only via the `MiPermit ` system on the Worcester City Council web-site or <u>www.mipermit.com</u>
- 5. Virtual season parking permits are issued by Worcester City Council following payment using a credit/debit card through the `MiPermit` system. The permit holder will be provided with a unique account in which to manage their parking. The Permit holder will be responsible for providing at least one vehicle registration number when registering to park using the `MiPermit` scheme. The permit holder will be responsible for updating their account if a different vehicle is being used to the one first recorded when registering to use the `MiPermit` scheme.
- 6. By purchasing a Virtual Season parking permit, you will not need to pay for or display a Pay & Display ticket in the windscreen of your car.
- 7. Permits are only available for vehicles not exceeding 2.2m in height.
- 8. Your virtual season parking permit will allow parking in any car park in your chosen zone at any time, every day of the week [including Sundays and Bank Holidays], every day of the year.
- 9. Season parking permits charges are;

 You must either purchase a virtual season parking permit or purchase a Pay & Display ticket to park in Worcester City Council car parks.

- 11. Failure to Pay & Display or pay to park via a virtual permit may attract the issue a Penalty Charge Notice.
- 12. Season permit holders parking in; -
 - St. Martins Gate Multi-storey car park are requested to park on levels four and five. If no spaces are available on those floors then the holder may park anywhere else within the car park [excluding motor cycle bays and bays reserved for Disabled blue badge holders or parent & toddler spaces.
- 13. Season permit holders parking in any other car park may park in any bay, other than those having drop down barriers, or marked out as restricted for example ` Disabled Drivers ` or ` Mother & Child `, ` Motor-cycles.
- 14. Possessing a season permit does not give the holder a right to park in any one particular parking bay nor guarantee a space being vacant.
- 15. Responsibility for renewing the season permit lies with the holder; this can be done via the `MiPermit` scheme. No reminders will be issued by Worcester City Council.
- 16. Vehicles using a virtual season parking permit must park within the marked bays. [Lines].
- 17. The council may suspend the use of any parking space or part thereof, whether occupied by a vehicle using a virtual season parking permit or not, for the following reasons; -

For the purpose of facilitating the movement of traffic or promoting it's safety.

On any occasion on which it is likely by reason of some special circumstances that parking within the car park[s] would be obstructed.

- 18. A Civil Enforcement Officer in uniform may move or cause to be moved in case of emergency to any place that is reasonably deemed to be fit, any vehicle parked in any parking space, whether using a virtual season parking permit or otherwise.
- 19. If there are no spaces available in the chosen car park, in other words the car park is full; the owner of the permit may park in any other car park in that zone. Should all of the

chosen zone car parks also be full, the permit holder must park elsewhere. If in a Worcester City Council owned car park by paying and displaying a Pay & Display ticket in the normal manner.

- 20. Refunds will be available pro-rata in full month units only.
- 21. Worcester City Council reserve the right to withdraw or cancel a permit at any time, if payment has failed.
- 22. Worcester City Council reserve the right to withdraw or cancel a permit if there is evidence it is being mis-used.
